NOW THEREFORE, the undersigned Declarant pursuant to and in accordance with the provisions of the Declaration, amends the Declaration as follows:

Paragraph 6.22 (b) of the Declaration is hereby deleted in its entirety and is replaced with the following:

(b) Xeriscaped yards or landscaping, including artificial turf, may be permitted but only upon written approval of the Architectural Control Committee.
